

Prize Draw Terms & Conditions:

Entry to this prize draw is automatic with a qualifying rental but the award of a prize is conditional upon your acceptance of these terms and conditions. Prior to any award of the prize, a winner may be required to reconfirm adherence to these terms and conditions.

Promoter and Participants:

1. The Promoter is Hertz Europe Limited with registered office address at Hertz House, 11 Vine Street, Uxbridge, UB8 1QE (company number 01008739) ("Hertz").
2. This prize draw is called: "1-week free car rental prize draw".
3. All entrants ("Participants") must be aged 18 or over on the date they enter the prize draw, and hold a current, full drivers' license to be eligible.

How to participate:
